


- (a) Advancement and propagation of education and learning including establishment, maintenance and support of school and other educational institutions.
- (b) To make provision to advance the cause of, and impart_Nursery, Primary, Secondary, higher, Commercial, Industrial, Technical, Physical any or any other type or kind of education
- (c) To establish, maintain, take over management, administer or run any institution/s, __colleges engaged imparting of education to student upto any level that may be found necessary and/or desirable.
- (d) To generally impart education to children and for the purpose to do all acts that may be necessary.
- (e) To establish, run, manage, and administer any institution/s or college or school to train persons to be teachers who will impart education to children and/or students in school, college and other similar institutions.
 - To promote adult education.
- To hold, arrange and organize meetings,

lectures, talks, discussion, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, audio-visual programmes, the artistic performances and other cultural activities, sports and games.

- (h) Establishment, maintenance and support of libraries, museums and reading rooms and distribution of book etc, for advancement of education and knowledge in particular and general as well.
- (i) To provide and meet all expenses of the school and other educational institution/s.
- (j) Advancement and propagation of education and learning including establishment, maintenance and support of schools, college, pathshalas and other educational institutions auditoriums, professorship, lectureship, scholarship and prizes etc.
- (k) Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time.

- (a) That above first board of Trustees, except member Trustee shall be life time Trustee. Member trustee/s shall—retire at the end of every period of three years their places being filled in by the life time board of trustees after final approval of General Secretary.
- (b) That the Board of trustee/s shall constitute a school/colleges/others managing committee/s for each of the school/college/s run by the Trust in accordance with the rules for the time being in force. The function of such solely advisory committee/s on relating to organization, management and administration of school/college. The Board of trustee/s are also authorized to constitute such other advisory Bodies as they deem fit and proper for the smooth and efficient running of school/colleges run by the Trust.
- (e) That the Board of trustee/s shall constitute as many sub-committees as may be necessary or expedient from time to time for the

expedient from time to time for the management of the various institutions of run by the Trust with the consent of General Secretary.

(d) That the Board trustee/s with the consent of General Secretary by themselves or through agent/s employed by them manage and deal with the Trust property in such manner as may be most beneficial to the interest of the Trust and shall have power to acquire, lease, sell, mortgage and purchase properties according to the circumstances and also raise loans, overdrafts from Bank, from any person/s or other sources and to spend the monies for purposes for which the Trust has been created subject to the rules in this direction and approval of General Secretary.

(e) That the Board of trustee/s shall have power to amend, alter or rescind the rules and to interpret their meaning whenever the rules and bye-laws framed do not cover any emergency or are ambiguous provided that such change or interpretation does not conflict with the aims and objects of the trust. It any difficulty arise in giving effect to the provision/s of the "Trust deed" the majority of the Board of trustees including General Secretary may, by circulation or otherwise make such provisions not inconsistent with the Trust Deed as appear to be necessary or
